

URGENT: MEDICAL DEVICE CORRECTION
BCI Airway Adapters

Smiths Medical is issuing this letter to notify you of a potential issue with specific Airway Adapters supplied individually and with certain kits. This letter details the issue, the affected models and lots, and the required actions for users to perform.

Issue:

Smiths Medical has become aware of the potential for breakage of these Airway Adapters. Investigation determined that the weld between the mating parts may not meet specification. Please reference the correctly assembled view in *Figure 1* and the separated components in *Figure 2*.

Potential Risk:

The issue may be detected at setup, however if the Airway Adapter breaks after therapy is initiated, inaccurate readings, a break in the airway circuit and loss of ventilation are also possible. A break in the airway circuit could result in an inability to ventilate, hypoxia, cardiopulmonary collapse or death.

If this issue occurs, the breathing circuit must be reconnected using a new Airway Adapter to address the issue. Smiths Medical has received two (2) complaints related to this issue. Of those two (2) complaints, there were zero (0) reports of death, and zero (0) reports of serious injuries associated to this issue.

Affected Product:

Our records indicate that your facility may have received potentially affected products. Refer to Table 1 below for a list of affected devices and lot numbers.

To address the described risk, users should follow the instructions below:

1. Check all inventory locations within your institution for the affected product listed in this notification. If you have an affected product quarantine it.

2. Destroy all affected products following your institution’s process for discarding. If discarding is not immediately possible at your facility, then the product should be quarantined until disposal.
3. Share this notification with all potential users of the devices to ensure they are aware of this notification. If the devices are used at another location, please ensure this communication is delivered there.
4. Complete and return the attached Customer Response Form to smithsmedical8046@sedgwick.com within 10 days of receipt to acknowledge your understanding of this notification. Please contact customer service for a credit.


